RE-NOTIFICATION

Applications are invited from qualified candidates for appointment to the post of **Professor** in the following Teaching Departments of the University in the **Academic Level 14**.

Appointments to the posts will be made in accordance with Section (6) Sub Section (2) of Chapter II of the Kerala University Act,1974, and UGC Regulations 2018.

The turn of appointment as per the principles of rotation is given against each post. Candidates outside the State are eligible to apply only for the 'Open' category.

Qualifications:

Qualifications are as prescribed by the UGC in the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018.

Age: Not more than 50 years as on 01.01.2022.

Usual relaxation in the upper age limit shall be allowed in respect of candidates belonging to SC/ST and Other Backward Classes. Relaxation in the upper age limit will also be allowed in the case of persons already in the regular teaching service in the Departments/affiliated colleges under the University of Kerala and UGC qualified technical staff (non-teaching) in the University of Kerala.

Registration Fee: Rs.2100/- (Rs. 1050/- for SC/ST Applicants)

Mode of remittance of Registration Fee:

- a) Registration fee can be remitted **online**.
- b) Postal Orders, Money Orders, Cheques and DDs **will not be accepted**.
- c) Fee once remitted will not be refunded.

How to apply:

The applicants are required to apply through online mode (<https://recruit.keralauniversity.ac.in>). Online submission of application will be entertained till **03.09.2022** and the applicants will have to submit hard copies of the printout of online application along with self-attested copies of the supporting documents and fee receipts towards Registration Fees, so as to reach the Registrar University of Kerala, Thiruvananthapuram – 695 034 on or before **5:00 pm on 05-09-2022**. Submission/addition of any documents after the last date for receipt of applications will not be entertained. Candidature of those who have registered online and failed to submit hard copies of application will be invalidated.

The applicants are required to provide a working **email ID and cell phone number** in the application. Since all communications in connection with the recruitment will be sent to the registered email ID, the candidates are directed to check their email periodically.

Separate applications with separate fees shall be required for applying to posts in different Departments.

Applicants who are employed should forward the hard copies of application through proper channel or enclose NOC of employer. Late and defective applications will be summarily rejected.

Applicants who have passed their qualifying examinations from Universities other than University of Kerala should furnish an **Eligibility Certificate issued by the University of Kerala**, stating that their qualifying degrees issued by other Universities, are recognized by the University of Kerala, along with their application.

OBC candidates have to produce certificate issued by competent authorities, certifying that they do not belong to the Creamy Layer in order to be considered for posts reserved for OBC categories. OBC and SC/ST candidates have to produce community certificates issued by competent authorities, if claiming age relaxation.

Applicants are required to produce sufficient documentary proof in respect of the claims/credentials made in their applications, along with the following:

- 01.** Copies of all certificates in respect of UG, PG, Additional PG, MPhil and PhD Degrees
- 02.** Mark lists of PG Degree
- 03.** Certificate to prove percentage of marks of PG Degree, where grading system is followed
- 04.** Certificate of experience of teaching in University/college as Assistant

professor/Associate professor/Professor and / or research experience at equivalent level at the university/National Level Institutions (Teaching Experience, acquired as regular teacher in University Departments/Government and aided colleges/State and National Institutes will only be counted).

05. Copies of 10 publications (Minimum) in the peer reviewed or UGC listed Journals.
06. Disability certificate issued by competent authority for claiming reservation in posts reserved for differently abled.

All certificates/Mark lists/publications/other certificates which are relevant, claimed by the applicant should also be uploaded in PDF format.

- All qualifications/experience/credentials claimed should have been acquired as on the last date of receipt of applications.
- Proforma for calculation of Research Score duly filled in with supporting documents (Proforma provided online) to be submitted along with hard copy of the application. Those claims that are not supported with documentary proof, where required, will not be considered for calculation of research score. List of candidates found eligible for interview will be uploaded in <https://recruit.keralauniversity.ac.in>. The approved templates for calculation of research score and selection process is as per U.O.No.Ad.DII/General/UGC-R 2018/2022 dated 27.06.2022 uploaded in the University website.
- The University reserves the right to accept/reject the applications or to re-notify the post without assigning any reason.
- Candidates, if called for interview, should appear for the same at Thiruvananthapuram at their own expense. Submission of application does not entitle the applicant any right to be appointed or be called for interview.
- Any addition/Corrigendum will be hosted in the University website only. So the applicants are advised to keep in touch with website for updates.
